#### 1. Call to Order

#### 4. <u>Budget Update</u>

- YTD Financials Mr. Helsen shared the balance sheet as of September 30, 2022, the profit and loss statement, the Choice One Bank statement, and the Community Foundation statement. ### 5. Membership Update

• Term Review – Randy Lindquist and Megan Byard Karaba reviewed the terms of current membership with the Board.

## 6. <u>Student Eligibility, Terms & Appeals</u>

- 2022 Cohort Summary Review & Update Mrs. Byard Karaba reminded the board of the location of the 2022 Cohort data in the PZA Board Sharing Google folder.
- MI Achievement Scholarship Press & Effect on Zones Mrs. Byard Karaba shared information about the new State of Michigan scholarship (starting with the 2023 graduates who meet financial thresholds set by the state) being signed into law this month. Promise Zones are seen as gift aid similar to PELL and TIP as part of this new statewide scholarship opportunity. We will need to look at the new projection and forecast models to see what the impact will be on the Muskegon Area Promise.
- Goals and Strategy Subcommittee Mrs. Byard Karaba reviewed the current subcommittee assignments. Unassigned members have been given an option to join subcommittees as they see fit. With new financial information, the Goals and Strategy subcommittee will need to meet to start discussing growth and potential change to our Promise Zone awards. Holly Hughes suggested the work could be a full Board activity. All Board members will be invited to participate in the Goals and Strategy meetings. Megan will be sending out a Doodle Calendar Poll to find a date and time beginning in November. Meetings will meet in person, but will also have an option to join via Zoom.

#### 8. Marketing/Communication Update

- Promise Professionals 2.0 Mrs. Byard Karaba suggested new digital marketing efforts, including a microsite concept like MCAN has used for their annual report. Megan is working with Ben Kalb, MAISD Director of Communications, on building a microsite for a Muskegon Area Promise marketing campaign. The goal is to have this completed by the December holiday. Once the site is built we are hopeful to use different digital outlets to drive traffic to it. A print piece has also been encouraged to accompany the digital effort.
- 2023 Equity Project (Super Students) Update October is MI College Month and Maaike Mudde, Youth Impact Adviser for the Promise Zone, is working with districts (Muskegon, Muskegon Heights, Holton, Muskegon Covenant Academy) and their students to spread the Promise message. Mailings and in-person student gatherings are being planned.
- LCAN/Promise Counselor Presentation Fall 2022 Mrs. Byard Karaba shared that a recent meeting was held with area counselors updating them on the efforts and focus of the LCAN and Promise Zone. Megan included a copy of the presentation in the PZA Board Sharing Folder for review.
